**Treasurer Report:** General Fund \$16,428, Heritage Fund \$399,896, March expenses \$15,938 (includes one time organ installation expense), March collections \$7417, March capital campaign \$9720, total capital campaign \$29,330. Investment committee (Cathy B, Pat G, Phyllis Y, Sarah T) met with Raymond James and approved fund reallocation to laddered CD's and moved funds from Norris Pernet French to Dearborn Partners as recommended by Carla Masselink, our fund manager. Discussion re: need for outside audit, if organ expense should come out of general fund and pastor salary discrepancy.

**Clerk:** A service for Molly Baker will be this summer. Twins Nathaniel and Isaac were born to Amber & Tim Wyngarden on March 28<sup>th</sup>.

**Moderator Report:** Discussion about updating all church guidelines, policies and procedures. All board members to review the workflowy list pertaining to their position (found in members' area of our website). then copy and paste into a document, edit, and send to the church secretary. Gentry to create a wedding coordinator job description.

**Delegate Report:** No emails have arrived from NACCC. Has interest in attending annual meeting in Milwaukee but registration fees are not covered through the Delegate travel account in the church budget.

**Pastor Report:** Lenten soup suppers were successful with 15 regular participants. Thanks to all for Lenten-Easter music, poetry, and art. Holy Humor Sunday theme is "The Price is Right". Set-up will be April 15. Capital campaign goal is \$65,000. August 5, 2023 will be a fundraising BBQ dinner. Another fundraising idea is a church envelope wall \$1-\$100 (would generate \$10,100). Sarah will be contacting Sun Ray signs regarding a "Donor Tree" design that would be a good late summer or fall event for the Capital Campaign.
