Treasurer Report: As of 10/31/22, there is \$17,203 in the general fund checking. The unrestricted Heritage fund balance is \$68,570 which is down due to YTD losses & draws. YTD Money Market transfers are \$45,000. October budgeted expenses were \$10,799 and collections were \$7922. Parking lot donations through October were \$11,524. Budget worksheets were distributed with plans of approving a proposed budget at next month's BOM meeting.

New Business:

Parking Lot Donation: Request was received from SHS Band parent to collect parking fees in our lot for some summer weekends. Motion to deny request (Yff/Gentry). Unanimous approval.

2023 Budget: Pastor Salary will see an increase of 10% of the wage portion of employment package which was \$56,000 in 2016. Organist will receive an 8% COLA.
